Medical reasons

Serious illness, <u>including COVID</u>, serious accidents or death, counter-indication and post-vaccination, preanancy complications.



Personal reasons

Summons in preparation of adopting a child, as either a witness or jury member or for an organ transplant, to a retake exam, separation.



Serious vehicle damage

Maximum 48 hours before departure.



Business reason

Cancellation or change to paid leave, Redundancy / contractual termination, Professional transfer, Getting a job.



Absence of vaccination

Cancellation in case of absence of vaccination against COVID-19: In the event that, at the time of booking, the country of destination did not require a vaccination, contraindication of vaccination or postponement of appointment times to receive the COVID-19 vaccination as required by the health authorities...

Other guarantees: Serious damage at professional or private premises, theft of identification card, driving license or passport, refusal of boarding in case of temperature check...



Cas contact

Symptoms of COVID-19 confirmed by a medical opinion, or having come into contact with a person infected with COVID-19.
